

The occupational health and safety management system keeps becoming stronger every day, thanks to the commitment of each employee. We started 2022 with a compliance of 65.75%, and we begin 2023 with a compliance percentage of 93.25%.

PREVENTING

OCCUPATIONAL ACCIDENTS!

To begin with, we must remember what an occupational accident is. According to Article 3 of Law 1562 of 2012, an occupational accident is defined as "any sudden event that occurs because of or in connection with work, and that produces in the worker an organic injury, a functional or psychiatric disturbance, a disability or death".

Therefore, it is truly an occupational accident when the employee is performing an activity directly related to his job function. And it is also considered a work accident when the person is carrying out orders from his boss.

What does OROMETRO S.A.S do on regards of preventing work accidents?

- Implementation of self-care and safe workplace campaigns.
- Implementation of epidemiological surveillance programs.
- Constant training through the ARL and external consultants.
- Active participation of each of the members of the committees in the interest ofprevention
- Creation of training plans according to the needs of each area.
- Constant updating of the hazards and risks matrix, engaging each collaborator.

Have these strategies worked to reduce the accident rate?

Yes, in 2021 we closed the year with 13 accidents and in 2022 we saw the fruit of the effort and the self-care culture adopted by each OROMETRO S.A.S employee, since we closed the year with 3 accidents.

In 202<mark>3 w</mark>e continue betting on the zero-accidents-at-work campaign. Remember: a safe day is a great day!



SAGRILAFT

IT IS TIME TO REMEMBER THE BASIC CONCEPTS OF SAGRILAFT!

As we all know, SAGRILAFT is defined as the system of self-control, prevention and comprehensive risk management against money laundering, terrorist financing an financing of the proliferation of weapons of mass destruction, and it refers to the possibility of loss or damage to a company, directly or through its operations, should it be used as an instrument for money laundering and/or channeling resources to carry out terrorist activities or financing the proliferation of weapons of mass destruction, or when the intention is to hide assets derived from such activities.

For this reason, since 2019 OROMETRO S.A.S has implemented the SAGRILAFT system with a focus on continuous improvement which involves constant training to its employees. That is why, in this edition of OROTÍN we will remind you of each of the crimes that must be managed.

Asset Laundering: Asset laundering seeks to conceal or disguise the nature, origin, location, ownership or control of illegally obtained money and/or goods. It involves introducing into the economy, assets of illicit origin, giving them the appearance of legality by making use of licit activities, which allows criminals and criminal organizations to disguise the illegal origin of their proceeds, without jeopardizing their source.

Financing of Terrorism: Financing of terrorism is understood as the criminal activity by means of which resources of licit or illicit origin are used to finance terrorism, terrorist acts or terrorist organizations.

Information and Analysis Unit (UIAF, for its Spanish acronym) the proliferation of weapons of mass destruction is "any act that provides funds or uses financial services, in whole or in part, for the manufacture, acquisition, possession, development, export, transfer of material, fractionation, transportation, transfer, deposit or dual use for illegitimate purposes in contravention of national laws or international obligations, when the latter is applicable".

DO YOU KNOW WHAT CORRUPTION AND TRANSNATIONAL BRIBERY ARE? DON'T WORRY, IT IS OUR DUTY TO CONSTANTLY REMIND YOU.

As is known to all, the Transparency and Business Ethics Program aims to prevent the materialization of the risks of corruption and transnational bribery. Through the controls, policies and procedures implemented, OROMETRO S.A.S, fights every day against this scourge. Below, we remind you what these risks are about.

Corruption: Corruption is a term that generally indicates the misuse by an official of his authority and the rights entrusted to him, as well as the authority related to this state official, opportunities, connections for personal benefit, contrary to the law and ethics principles.

Transnational Bribery: Also known as international bribery, this is an act of corruption that has a negative impact on the world economy and hinders the growth and development of countries.

Transnational bribery jeopardizes the competitiveness of countries, since it prevents international business or transactions from developing under equal conditions. This means that not all competitors have the same opportunities to access a certain market because others have paid a price to have preferences.

This crime occurs both in developing countries and in those with a strong economy and it is mainly caused by the lack of adequate controls to detect and prevent corrupt conducts, as well as by the lack or inefficiency of business ethics and transparency programs.

After a year of working on the implementation of the BASC control and security management system, in November 2022 we received the certification audit. As a result of this auditing process, OROMETRO S.A.S obtained the certification issued by the WORLD BASC ORGANIZATION, which indicates that the Company meets all standards and safety requirements established by norm at the different stages of the supply chain.

For us, as a company, it is very important to inform all interested parties that OROMETRO S.A.S. has this certification, since this guarantees that all our processes are standardized and comply with strict security controls throughout the processes of buying and selling precious metals.
