C.I. OROMETRO SAS is committed to the prevention of **Musculoskeletal Disorders** (**TME**, for its Spanish acronym) as these are the cause of pain and discomfort that hinder the quality of life, so we have developed the following strategies to mitigate them:

- Perform workplace inspections
- Execute symptomatologic surveys
- Ensure daily active breaks
- Promote recreational relaxation activities
- Implement campaigns on correct posture
- Provide continuous training by a physiotherapist

Our aim is that our collaborators work in a safe environment and that through each of the activities listed above they can reduce stress, eliminate injuries and disorders associated with overuse of muscles, poor posture and repetitive tasks.





PREVENTING

Prevention of Psychoactive Substances (PAS): Brain functioning, protective factors and risk factors

What is problematic use of psychoactive substances?

A drug use becomes problematic when it affects the user's health, his/her relationships with family and friends, when it alters daily activities such as work and study, or when it involves economic problems or problems with the law.

How do PAS work in our brain? Withdrawal syndrome and tolerance to consumption.

TOLERANCE TO PAS is a process through which a certain dose of the substance produces a progressively lower effect as its administration is repeated, thus forcing the individual to use progressively higher doses in order to achieve the original effect. As for ABSTINENCE SYNDROME, it refers to a series of acute signs and symptoms that occur at the physiological and psychological level as a result of the interruption of the consumption of a certain substance, which lead the consumer to administer one or more doses again to mitigate these effects, which can range from headache and nausea, to panic attacks and convulsions.

What are protective factors and risk factors regarding psychoactive substance use?

PROTECTIVE FACTORS are individual, family, or social characteristics or attributes that reduce the likelihood of psychoactive substance use, abuse or dependence.

- ✓ **Individual factors:** high self-esteem, social skills, ability to cope with problems, among others.
- ✓ **Family factors:** Good communication, parents who are affectionately close, good family attachment, establishment of rules and limits, etc.

✓ Social factors: Participation in community activities, regulations regarding psychoactive substances, access to health and education services, among others.

RISK FACTORS are individual, family or social characteristics or attributes that lead to or increase the use of psychoactive substances.

- ✓ Individual factors: low frustration tolerance, aggressive behavior, low selfesteem, among others.
- ✓ **Family factors:** Use of psychoactive substances by parents or caregivers, authoritarian discipline, overprotection, lack of parental or caregiver supervision of children's activities, domestic violence, among others.
- ✓ **Social factors:** Low support from social networks, availability of psychoactive substances, use of psychoactive substances by peers, violence in the school and social environment, among others.

What measures should I take regarding the use of psychoactive substances?

Identify your consumption pattern

Asking yourself what substances you consume, in what quantity, in what situations and how often will give you clues about the type of consumption you have and the actions you should take about it.

Voluntarily reduce your consumption level

Take control of your relationship with psychoactive substances and take charge of the situation by decreasing the frequency or amount of consumption. Start other activities that give you pleasure and allow you to develop new skills.

Seek help

If you think that your level of consumption has become problematic, seek medical and psychological help.

Listening services

IDENTIFICATION AND REPORTING OF UNUSUAL, SUSPICIOUS AND ATTEMPTED OPERATIONS.

Each one of you, as a fundamental part of SAGRILAFT system, have the obligation to constantly be aware of any alert signal that may arise in the performance of your duties, and thus be able to report them to the company's Compliance Officer for subsequent analysis and to establish whether this alert signal becomes a Suspicious Operation, an Unusual Operation or an Attempted Operation.

For this reason, you are again reminded to be aware of each event so that together we can fight against the materialization of ML/FT-FPADM.

However, we will remind you of the meaning of these terms.

Warning Signals: warning signals are those situations that break away from the particular behavior pattern of a customer or of the market, thus being atypical and therefore requiring further analysis to determine whether there is a possible money laundering or terrorist financing operation in progress.

Attempted Operation: Operation in which a natural or legal person intends to carry out a suspicious operation, but does not perfect it because the person who intends to carry it out desists, or because the established or defined controls have not allowed him/her to carry it out,

Unusual Operation: A transaction whose amount or characteristics does not correspond or conform to the ordinary or normal economic activity of the company, or whose number, amount or characteristics do not fall within the guidelines of normality or ordinary business practices in a sector, industry or with a type of counterparty.

Suspicious Operation: is an unusual operation that, in addition, cannot be reasonably justified according to the uses and customs of the activity in question. This type of

transaction includes attempted or rejected transactions that contain characteristics that make them suspicious.

Knowing this, it is important for you to know that with each of the reports you make to the Compliance Officer of detected alerts signals, he will analyze them, fit them into any of the operations already defined and, if necessary, will make a suspicious operation report.

The suspicious operation reports (SOR) are the reports that must be sent to the Financial Information and Analysis Unit (UIAF, for its Spanish acronym) by the companies required to do so, informing the occurrence of an unusual, unjustified operation within the company.

The submission of this report is the responsibility of the Compliance Officer and must be made immediately after the unusual operation is classified as suspicious.

WARNING SIGNALS: PTEE (Transparency and Business Ethics Program)

As with SAGRILAFT, there are warning signals within the PTEE. These warning signal are situations that break away from the particular behavior pattern of a customer or of the market, thus being atypical and therefore requiring further analysis to determine whether there is an unlawful operation in progress, which in this case would be corruption and/or bribery.

For this reason, should you detect anomalous situations regarding coworkers accepting benefits (whether economic or any other kind) to expedite services and acceptances within the company, do not hesitate to report them to the Compliance Officer, who will take care of the rest.
