TODAY WE WANT TO HIGHLIGHT OUR SYSTEM!

Orometro SAS has implemented strategies to strengthen its occupational health and safety management system every day, with the sole purpose of guaranteeing all its workers that every effort is made to prevent any type of occupational illness or accident. Thanks to these measures, we have begun to see positive results and to date we are at 82% compliance.

This compliance rate is the result of the joint work that we have built as each collaborator has done his/her share to make our system operate in the best way. We will continue working together for the health and safety of each of our collaborators.



ALCOHOLISM!

To begin with, we must remember that alcoholism is a disease that generates a strong need and anxiety to ingest alcohol, so that there is a physical and psychological dependence of the individual himself/herself, manifesting itself through various withdrawal symptoms when consumption is not possible. The alcoholic has no control over the limits of his/her consumption, which increases as tolerance to this drug develops. It is considered a chronic, progressive and fatal disease.

What are the stages of alcoholism?

- **Pre-alcoholic stage:** The individual uses alcohol to relieve or cope with unfavorable emotional states. As the dose is progressively increased, the body becomes accustomed to it and tolerance develops. The person's daily life is not affected.
- **Prodromal stage:** It is characterized by being very progressive. The person's need for consumption increases. In this phase, the person usually start to drink beverages of higher alcoholic content or drink on the sly.
- **Critical stage:** When the person starts drinking, he/she cannot stop. The individual loses form and control, with mood swings. Family, work and social spheres are affected, since these tasks are neglected. Self-deception and the feeling of false control are characteristic of this phase. The first consequences on the individual's health begin to appear.
- **Chronic stage:** It is defined by the appearance of withdrawal syndrome, which determines that the state of drunkenness is almost perpetual. There is social, family and work uprooting and problems are generated on all fronts. The consequences on the individual's health are already clearly advanced.

What does Orometro SAS do about this problem?

- It adopts measures to counteract the harmful use of alcohol
- It provides accompaniment and monitoring of staff suffering from this type of disease.
- It promotes training spaces so that each employee becomes aware of this problem.

As we all know, OROMETRO S.A.S., has implemented a Transparency and Business Ethics Program (PTEE, for its Spanish acronym that is responsible for preventing the materialization of the risks of corruption and transnational bribery, as these two scourges are a problem that our country is currently facing.

Today we want to tell you a little about transnational bribery according to the postulates of the Superintendence of Corporations:

First of all, we must understand that transnational bribery is the same as international bribery. It is the conduct performed by a legal person or a branch of a foreign company domiciled in Colombia, through any of its employees, managers, associates, contractors or subordinate companies to give, offer or promise to a foreign public servant -directly or indirectly- sums of money, objects of pecuniary value or any benefit or utility in exchange for such public servant to perform, omit or delay any act related to his functions and in connection with an international business or transaction.

REMEMBER THAT BRIBERY IN ANY OF ITS MODALITIES IS CLASSIFIED AS A CRIME!



WE HAVE STARTED THE PROCESS FOR BASC CERTIFICATION!

As we all know, OROMETRO S.A.S. had among its purposes to become certified in BASC (Business Alliance for Secure Commerce, and this has already become a reality. On April 19th, 2022, we were visited by an International BASC Auditor who conducted an awareness raising session in the offices in Medellin. The process leaders and the General Manager of Orometro SAS participated in this event.

The purpose of the afore-mentioned session was to let us know what BASC is, the benefits that certified companies receive, what the process for certification is, what aspects to consider in order to strengthen traceability in the supply chain in terms of prevention of money laundering and terrorist financing, physical security, stakeholders, etc.

Once this awareness has been carried out, Orometro SAS will have nine months to implement its BASC Control and Security Management System.


